Also in the TIP is the rehabilitation of the truck loop used to access the Willow Lift Bridge.

The new State Street Bridge will provide reliable access for all modes of transportation, while implementing measures to mitigate the effects of industrial uses upon captive adjoining residents and increasing numbers of recreational users. The project also includes improving the truck route leading to the new

bridge, which borders along Lakeview Terrace, a public housing complex constructed in the 1930s and owned by the Cuyahoga Metropolitan Housing Authority (CMHA). The project will alleviate air quality by reducing truck travel lengths and idling times, and by constructing roadside barriers. The project will seek to mitigate noise and traffic congestion by exploring new technologies.




