By indicating your acceptance, you (on behalf of yourself and/or minor child/ward) understand, agree, warrant and covenant as follows:

Liability and Publicity release: I know participating in an adventure race is a potentially hazardous activity, and I (my minor child/ward) should not engage in running, cycling, and paddling unless I (my minor child/ward) am medically able to do so and properly trained. I agree (on behalf of myself and minor child/ward) to utilize appropriate safety equipment, including but not limited to, a bike helmet, United States Coast Guard approved lifejacket, and a leash (for stand up paddleboarding). I (on behalf of my minor child/ward) further agree to refrain from the use of alcohol and any illegal drugs before or during the race. I (on behalf of myself and minor child/ward) assume all risks associated with running, cycling, canoeing, stand up paddleboarding, and/or kayaking in this event including, but not limited to: falls, trips, struck by, struck against, compressed in, caught in between, entangled, rubbed, abraded or jarred by vibration from equipment or materials, trail and water conditions, course conditions, traffic, effects of weather, contact with other participants or the natural environment or other cycles or vehicles, misuse or failure of equipment, drowning, and collision with another craft, person, or object in the water, illness, disease or infection, and agree for myself (and on behalf of my minor child/ward) to fully release, hold harmless and indemnify the Board of Park Commissioners of the Cleveland Metropolitan Park District, its officers, employees, agents, sponsors, and volunteers and Paddle the River, LLC, its officers, employees, agents, sponsors, and volunteers (collectively, the "Releasees") from any and all claims related to any illness, injury, including loss of life, property damage, or loss of any other description which I (or my child/ward) may sustain arising out of, or in any way associated with, my (my child's/ward's) participation in the Ledges to Lake Adventure Race even though liability may arise out of the negligence or carelessness of the Releasees. In the event of injury or illness, I authorize (on behalf of myself and my child/ward) Cleveland Metroparks and Paddle the River, LLC to obtain first aid and/or medical treatment at the nearest and most adequate facility of Cleveland Metroparks' or Paddle the River, LLC's choice. I am aware staff/volunteers may provide support for this program/event, including but not limited to the administration of: first aid, CPR (cardiopulmonary resuscitation), or the use of an AED (automated external defibrillator) and give permission for Cleveland Metroparks and Paddle the River, LLC to provide such care to me (my minor child/ward). I further give my permission for the free use of my (my child/ward) name, voice recording, or photo in any print account broadcast, telecast, or commercial advertising of the event or for other uses, including but not limited to commercial use by Cleveland Metroparks, Paddle the River, LLC, or any of their officers, employees, agents or sponsors. It is agreed that this document shall be interpreted according to the laws of the State of Ohio.
