#### (b) Request for Approval of Modified 2024 Rates and User Fees

The Board approved the 2024 Rates and User Fees Schedule on October 19, 2023 pursuant to Board Resolution No. 23-10-156 and approved revisions to certain Police fees on January 18, 2024 pursuant to Board Resolution No. 24-01-007. The Schedule includes the ability to make reasonable modifications to certain golf and enterprise rates and fees based on market conditions. Staff requests a modification to the Zoo Rates and User Fees to include that same flexibility to address market conditions as set forth in the modified Zoo Rates and User Fees included herein (see pages <u>100702</u> to <u>100703</u>). The remainder of the 2024 Rates and User Fees Schedule shall remain as approved on October 19, 2023 and January 18, 2024.

## (c) Club Metro 2024 Financial Request

(Originating Sources: Charlie Rosol, Club Metro President/Aulbrie Kitson, Club Metro Treasurer)

## **Background**

Club Metro, the non-profit employee club for Cleveland Metroparks, wishes to extend appreciation to the Board of Park Commissioners for its financial support of \$6,500 in 2023.

With financial support in 2023, Club Metro helped support employee activities through networking/social events (employee picnic, holiday party, tobogganing, etc.), charitable events, and support of Charity Choice.

Club Metro's 2024 membership currently includes 175 Cleveland Metroparks employees and retirees.

In 2023, Club Metro earned \$9,854.99 from activity fees and \$7,720.00 from membership dues from current/new employees and retirees (at \$40.00/employee). An agreed upon procedures (AUP) engagement was performed for the year ended December 31, 2023. An AUP is an attestation engagement that involves performing specific procedures and reports any findings without providing an opinion or conclusion. The procedures performed included: reconcile the December 31, 2022 and December 31, 2023 cash balances to bank statements; review and trace individual revenue transactions appearing in Club Metro accounting records to bank statements to validate the source and

amount of at least 75% of all receipts and disbursements recorded in 2023; review randomly selected receipt and expense transactions for propriety, including appropriate approval and documentation, and correct financial state classification; reconcile all amounts presented on the Statement of Cash Receipts, Cash Disbursements, and Changes in Fund Balance of Club Metro to underlying accounting records, and note any activities subject to unrelated business income tax, excise tax or other tax, and review whether required filings with tax authorities are up to date. The AUP engagement was performed by Cleveland Metroparks Finance Staff and is on file with Club Metro President Charlie Rosol, Treasurer Aulbrie Kitson, and Cleveland Metroparks Chief Financial Officer Wade Steen, with no irregularities reported. As of December 31, 2023, the current treasury balance is \$4,205.91.

Activities planned for 2024 may include but are not limited to: volunteer work at the Greater Cleveland Food Bank, a summer picnic, a holiday party, float the river, hayride, and more. Members are given weekly discounts to over 100 various companies through membership in the Best Benefits Club (BBC).

#### (d) Authorization to Submit a Grant Application and Commit Funds: Outdoor Recreation Legacy Partnership (ORLP) Program – Irishtown Bend Park

(Originating Sources: Natalie Ronayne, Chief Development Officer/Sean E. McDermott, P.E., Chief Planning & Design Officer/Kristen Trolio, Director of Grants)

The Outdoor Recreation Legacy Partnership (ORLP) Program provides funds to acquire and/or develop land for outdoor recreation. The program funds projects in designated "Urbanized Areas" as defined by the U.S. Census Bureau. The program is funded by the National Park Service and in the State of Ohio, the program is administered by the Ohio Department of Natural Resources (ODNR).

Cleveland Metroparks, in partnership with LAND studio ("LAND") has submitted an application to ODNR for consideration under the ORLP to construct components of the future Irishtown Bend Park. Irishtown Bend is a hillside located in the city of Cleveland, just south of Lake Erie, on the west bank of the Cuyahoga River. For over 40 years, Irishtown Bend has been slipping into the Cuyahoga River; this potential catastrophic collapse would block the Cuyahoga River's federal shipping channel that supports over \$4 billion of economic activity annually. This imminent issue has catalyzed a partnership between nonprofit, for-profit, and government entities in Northeast Ohio, including Cleveland Metroparks and LAND, which has led to a \$65 million stabilization project

along the hillside that commenced in mid-2023. Once completed, the stabilized hillside will provide an opportunity to create a  $\pm 25$ -acre public waterfront park connecting Cleveland residents and visitors to 101+ miles of regional trails and greenspaces, to the Cuyahoga River, and to Lake Erie.

Plural Studio was hired to develop designs for the future Irishtown Bend Park and the current cost estimates are based on these publicly vetted designs. Cleveland Metroparks requests funds through ORLP for park components, including amphitheater and overlook plazas, picnic areas, open space, play areas, and a boardwalk. This request also includes necessary site preparation and finishes such as irrigation and landscaping. Cleveland Metroparks has already secured \$3.3M from the federal Congestion Mitigation and Air Quality Improvement Program to construct the portion of the Lake Link Trail that traverses Irishtown Bend. The park development components will complement this work. The match, as indicated below, for this grant request has been secured and/or is pending through LAND studio.

(e) Authorization to Submit a Grant Application and Commit Funds: Outdoor Recreation Legacy Partnership (ORLP) Program – Cuyahoga Riverfront Property Acquisition (Originating Sources: Natalie Ronayne, Chief Development Officer/Kyle G. Baker, Director of Real Estate and Senior Assistant Legal Counsel/Stephanie Kutsko, Senior Real Estate Manager//Kristen Trolio, Director of Grants)

The Outdoor Recreation Legacy Partnership (ORLP) Program provides funds to acquire and/or develop land for outdoor recreation. The program funds projects in designated "Urbanized Areas" as defined by the U.S. Census Bureau. The program is funded by the National Park Service and in the State of Ohio, the program is administered by the Ohio Department of Natural Resources (ODNR).

Cleveland Metroparks has submitted an application to ODNR for consideration under the ORLP to acquire via fee simple title a  $\pm 4.5$ -acre property (Permanent Parcel Numbers: 003-05-013; 003-05-014; 003-05-020) currently owned by the Ontario Stone Corporation ("Property"). The Property is located directly on the ship channel at the mouth of the Cuyahoga River at its confluence with Lake Erie in the city of Cleveland and is directly across the road/railway from Cleveland Metroparks Wendy Park in Lakefront Reservation (see map page **100705**). Acquisition and future restoration of the Property by Cleveland Metroparks is a unique opportunity to reclaim industrial land along the Cuyahoga River. Cleveland Metroparks has identified the Property as an important acquisition as it provides a protection and restoration opportunity along the Cuyahoga River and will add greenspace to an area identified as an Environmental Justice area and in a disadvantaged census tract as defined by the Climate & Economic Justice Screening Tool.

Cleveland Metroparks requests \$3,000,000 toward acquisition of the Property. Based on a verbal assessment from an Ohio Department of Transportation (ODOT) certified appraiser who is familiar with the Property and surrounding comparables, the approximate appraised value of riverfront parcels in this area is \$30.00/sf; the Property is approximately 196,020sf which results in a market value of approximately \$5,880,600. Additional budget items include appraisal and review appraisal fees, title, Phase I and II assessments, and closing costs.

#### (f) Mill Stream Run Reservation: Authorization to Submit Grant Application and Commit Funds – Recreational Trails Program

The Recreational Trails Program (RTP) is a cooperation between the Ohio Department of Natural Resources and the Federal Highway Administration to fund trail projects in the State of Ohio. Eligible projects under RTP include the construction of connector and loop trails and trailheads, as well as maintenance and repairs to existing trails. Cleveland Metroparks received funds from this program in 2018 for construction of the Engle Road Connector Trail in Big Creek Reservation, in 2020 for construction of the Eastern Ledge Trail on the K. Hovnanian property in Euclid Creek Reservation, and in 2022 for the Garfield Pond Loop Trail.

Cleveland Metroparks has submitted an application to the 2024 RTP for construction of the Wallace Lake Loop Trail. This project will complement the in-process construction of the new concession building, restrooms, and outdoor classroom at Wallace Lake. The paved, 10-foot-wide trail will traverse the Wallace Lake Picnic Area to connect the amenities throughout the site. This project will formalize connections from Wallace Lake to the existing all-purpose trail system in Mill Stream Run Reservation and includes two at-grade crosswalks over Valley Parkway. The trail will fully comply with ADA standards to ensure accessibility for all guests.

#### (g) Resolution to Accept Grant and Commit Matching Funds – Ohio Department of Natural Resources Boating Safety Education Grant

Cleveland Metroparks has been awarded \$30,000 from the Ohio Department of Natural Resources ("ODNR") Boating Safety Education Grant program to support its Division of Outdoor Recreation. The grant funds will be used to support paddling and sailing programs in urban areas in the Park District. Specifically, funds will outfit the new paddling hub at the restored Garfield Park Pond with new kayak/stand up paddleboard storage racks and an updated fleet of various sizes of stand up paddleboards. Funds will also be used to purchase youth specific sailboats for Lakefront Reservation programming and for advanced kayak instructor training. Cleveland Metroparks' cost share for the grant is \$10,000 to be paid as in-kind salaries for existing program staff from the Division of Outdoor Recreation.

#### (h) Professional Services Agreement – RFQu #6701 – Hawthorn Parkway Bridge Replacement, South Chagrin Reservation – Professional Construction Inspection Services for Cleveland Metroparks

(Originating Sources: Sean E. McDermott, P.E., Chief Planning and Design Officer/ Christopher Papp, P.E., Civil Engineer/Michele Crawford, Project Development Manager)

#### **Background**

On November 3, 2022, Cleveland Metroparks issued a Request for Qualifications (RFQu #6701) for interested parties to submit qualifications for Professional Consulting Services for Cleveland Metroparks Construction Inspections, Park-wide for a maximum period of 6 years, through 2029. Construction projects subject to this program are distributed throughout all eighteen (18) reservations comprising the Cleveland Metroparks system. Fee proposals were to be requested on a project-by-project basis by the consultant deemed most qualified for the project scope as the projects are individually identified.

## **RFQu Response and Analysis**

Cleveland Metroparks staff prepared RFQu #6701 and requested that the respondents

demonstrate qualifications relative to anticipated project scopes, which includes providing comprehensive inspection and testing services on capital projects and federally funded transportation projects. The professional services RFQu yielded nine (9) responses from highly qualified consultant teams. Statements of qualifications were reviewed by a panel of Cleveland Metroparks staff, including Keith Carney, Michele Crawford, Sean McDermott, and Chris Papp, pursuant to O.R.C. 153.69.

Through an independent evaluation of the qualifications, the review panel determined a short list of three firms and requested interviews to become familiar with key personnel and understand the general project approaches and ability to meet stated objectives.

Following the interviews, Quality Control Inspections, Inc. ("QCI"), DLZ, and Greenman-Pedersen, Inc. ("GPI") were the top-ranked firms. These selected teams have vast project experience and familiarity with upcoming capital project service scopes and can provide services for construction inspection and administration, project inspection, structural inspection, coatings inspection, traffic signal and lighting inspection, soils and aggregate inspection, construction engineering level 1/construction management, and construction engineering level 2 services as requested. QCI, GPI and DLZ have a strong corporate history and offices in Northeast Ohio. Furthermore, each selected firm has completed multiple project inspections of the scale and complexity of those that Cleveland Metroparks anticipates in the future and as a part of the RFQu. It was the consensus of the selection team that these firms all had qualifications and personnel that would benefit Cleveland Metroparks as it manages and inspects capital projects.

#### **Proposal Analysis**

Short-listed firms will be invited to submit pricing proposals to Cleveland Metroparks on a per project basis. A proposal was requested from GPI for Hawthorn Parkway Bridge Replacement ("Project"), a federally funded Local Public Agency ("LPA") administered project in the South Chagrin Reservation. Due to the Project parameters, GPI was deemed most qualified for the Project of the three (3) short listed firms. GPI has personnel available with extensive experience with bridges, railroad coordination and ODOT LPA projects. GPI proposed a not-to-exceed cost of \$189,451 billed hourly which will cover the following items:

- Schedule and administer all progress meetings
- Review and approve the contractor's schedule
- Administer the submittal process, DBE documentation interviews, and project bill of materials
- Establish and update the LPA files and support information
- Organize all close out documentation and following through on any ODOT audit deficiencies
- Provide active contract administration and full-time on-site observation and documentation of the contractor's work
- Complete daily construction activity reports
- Track weather conditions, materials, labor and equipment
- Collect all material documentation
- Utilize the project bill of materials (PBOM) to monitor and control the materials
- Schedule verification testing as needed and required
- Review and provide recommendations for project invoices, request for information and construction disputes
- Hourly rates vary from \$95/hr for a Structures Inspector to \$175/hr for a Project Manager or Construction Engineer Level 2

**No. 24-03-036:** It was moved by Vice President Rinker, seconded by Vice President Ittu and carried, to authorize the Chief Executive Officer to enter into a Professional Service Agreement for Hawthorn Parkway Bridge Replacement, as per RFQu #6701, in the South Chagrin Reservation with **Greenman-Pedersen, Inc.**, in the **amount not to exceed of \$189,451** for construction administration and inspection services as outlined above in a form acceptable to the Chief Legal and Ethics Officer, pursuant to the associated proposal dated February 13, 2024.

#### (i) Professional Services Agreement RFQu #6402, Amendment No. 8 Contract 1488 – Bridge Inspection and Engineering Support Program, 2019 to 2024; 2024 Bridge Inspections and Summary Reports Proposal

(Originating Sources: Sean E. McDermott, P.E., Chief Planning and Design Officer/ Christopher J. Papp, P.E., Civil Engineer/Sara Byrnes Maier, Principal Planner)

#### **Background**

The State of Ohio requires governmental entities to have an annual bridge inspection program for all bridges used by public vehicles. The Ohio Department of Transportation (ODOT) requires that the inspections be performed by an organization qualified and certified by ODOT to perform such work. An annual condition report for each roadway bridge is required to be uploaded to an ODOT database. Cleveland Metroparks' program also includes bridges that carry maintenance vehicles, golf carts, all-purpose trails (APTs), and several selected foot trail bridges that have longer spans or unique construction at least once every five (5) years. Please note that this is the last year of the 6-year contract. We will be evaluating qualified engineering firms this year for the next 6-year contract.

On March 14, 2019 (Board Resolution No. 19-03-037), the Board of Park Commissioners approved a contract with Arcadis US, Inc. (Arcadis) pursuant to RFQu #6402 for bridge inspection and/or bridge rehabilitation/replacement engineering design services for the period from 2019 through 2024. To date Arcadis has performed the required inspections for the 2019, 2020, 2021 and 2022 inspection years. The cost to provide the inspections was \$54,910 for 2019, \$93,070 for 2020 with an amendment of \$7,500 to provide specific additional load rating calculations as requested by ODOT (Amendment No. 1), \$69,105 in 2021 bridge inspections (Amendment No. 2), \$206,100 for bridge inspections and design in 2022 which included \$131,550 for Hawthorn bridge design (Amendment No. 3), \$23,400 to develop the 2022 Municipal Bridge Program applications (Amendment 5), \$151,780 in 2023 bridge inspections (Amendment No. 6), and \$25,270 to develop the 2023 second round Municipal Bridge Program applications (Amendment 7). To date, the contract amount plus all amendments (Amendments 1 through 7) equal \$657,035.

The completed 2023 bridge inspections included forty-nine (49) ODOT rated bridges that receive an annual inspection. In 2024 we anticipate ODOT will be performing inspections on thirty-four (34) bridges and Arcadis will be including those findings in the annual inspection report and rehabilitation plan, in addition to inspecting the balance of the ODOT rated bridges.

## Amendment No. 8

Given the need for the annual inspections and related bridge engineering services a proposal was requested from Arcadis. As a result of the proposal, the scope of Amendment No. 8 covers the required annual bridge inspections and reporting for 2024 of the Park District's ODOT rated structures, five (5) year bridge capital plan and on-call services as well as several if authorized services noted below.

## 2024 Annual Inspection Tasks included in Proposal

A proposal was requested from Arcadis to prepare the inspections, complete the necessary work for recording with ODOT and other services as needed. The proposed consulting fees of \$155,320 cover the below scope:

(j) Amendment No. 2 – Contract #1725 – Professional Services Agreement – West Creek Greenway – West Creek Reservation – Professional Design Services (Originating Sources: Sean E. McDermott, P.E., Chief Planning and Design Officer/Michele Crawford, Project Development Manager/Andrew Stahlke, Project Developer)

#### **Background**

On September 19, 2023, Cleveland Metroparks entered into a contract with E.L. Robinson Engineering of Ohio Co. ("ELR") pursuant to Request for Qualifications (RFQu) #6753 for professional design services for the West Creek Greenway ("Project") at West Creek Reservation. Cleveland Metroparks has managed design of the Project and ELR has provided structural design for a trail bridge over West Creek. Through a partnership between Cleveland Metroparks, the City of Parma, and West Creek Conservancy, the Project's desired outcome is to create an interconnecting 0.4-mile trail linking multiple neighborhoods in the City of Parma to West Creek Reservation, and is funded through a \$560,000 CMAQ grant and a \$729,310 Clean Ohio Trails Fund grant. The majority of trail design and project coordination is being completed by Cleveland Metroparks staff with augmentation of specific design scopes by design partners (i.e., bridge design). Final design will be completed by the end of 2024 and construction is expected to begin in the spring of 2025.

The contract with ELR for prefabricated bridge design criteria and detailed plans for abutments and substructure for the bridge over West Creek was established at \$49,669 via RFQu #6753 which is intended for professional design services contracts below \$75,000. With the need for additional services the contract value will exceed \$75,000.

During development of preliminary bridge cost estimates, it was determined that a designed multi-span steel beam bridge was significantly more cost-effective than a single-span prefabricated bridge. ELR was requested to provide a proposal to produce detailed plans for the steel beams, deck, and piers for the new bridge concept and to develop a hydraulic model to analyze the impacts of bridge piers within the West Creek floodplain. The contract was amended on February 26, 2024 by \$25,057 to establish a new total of \$74,726. Board action was not required for Amendment No. 1 as the total contract amount remained below \$75,000.

#### Amendment No. 2

ELR was requested to provide a proposal for additional if-authorized services to include bridge pier design updates, hydraulic analysis updates, and construction services. The pier design update is requested in order to consider a design with a smaller footprint pier and the hydraulic analysis update is requested to determine the impacts of trail alignment modifications which increase the number of mature trees that are preserved. Construction services include shop drawing review, bidding services, and onsite meetings as required. ELR is prepared to continue to coordinate with the selected contractor and Cleveland Metroparks through Project completion.

#### **Proposal Analysis**

A proposal was requested from ELR to continue professional services for the Project scope as described above. ELR's proposed if-authorized not-to-exceed cost of \$18,624 will cover the following scope items:

# (k) South Chagrin Reservation – Solon to Chagrin Falls Trail – Phase 2: Authorization of Grant Submittal to Clean Ohio Trail Fund

(Originating Sources: Sean E. McDermott, P.E., Chief Planning and Design Officer/Sara Byrnes Maier, Principal Planner)

Cleveland Metroparks proposes to submit a grant application to the Ohio Department of Natural Resources ("ODNR") Clean Ohio Trail Fund ("COTF") Program to design and construct Phase 2 of the Solon to Chagrin Falls Trail. This  $\pm 0.3$ -mile all purpose trail ("APT") connector including a new bridge over the Aurora Branch of the Chagrin River will link the end of Phase 1 at the City of Solon-Village of Bentleyville corporate line to the existing Cleveland Metroparks trail to Chagrin Falls at Chagrin River Road.

#### **Background**

Cleveland Metroparks' *Second Century of Stewardship System Plan* identifies "Connections" as one of six core goals of the agency. To achieve this goal, staff collaborate on and are involved in community master planning and trail planning efforts to develop neighborhood connectors as well as regionally significant trails.

#### Phase 1

The City of Solon and the Cleveland Metroparks entered into a collaborative Project Development Agreement ("PDA"), effective March 24, 2022, which established the formal partnership and responsibilities of the parties towards the mutual development of the Solon to Chagrin Falls Phase 1 Project (Board Resolution No. 21-12-182). Phase 1 includes the design and construction of a 10' wide paved all-purpose trail that will connect Solon to Chagrin Falls from SOM Center Road to the northern corporation line along the former Wheeling and Lake Erie Railroad Company corridor. Phase 1 includes trail development, trailhead development, amenities, supporting infrastructure, bridges and related or complementary work. On December 6, 2023, the PDA was amended to reflect updated Project conditions. Subsequently, Solon established the maximum expenditure on the trail portions of the project at \$5,985,500. The target construction start date is May 2024 and completion during summer 2025 is anticipated for Phase 1, barring any unseasonal weather or material procurement delays.

As a condition of the Phase 1 PDA, Cleveland Metroparks committed to completing Phase 2 of the project within 12 months of completion of Phase 1, or approximately summer 2026. A map of Phase 2 of the Solon to Chagrin Falls Trail is referenced on page <u>100709</u>.

#### **Current Request**

Cleveland Metroparks seeks \$500,000 in construction funding for the Solon to Chagrin Falls Trail Phase 2 from the Ohio Department of Natural Resources Clean Ohio Trails Fund. The total cost of design and construction for Phase 2 is approximately  $\pm$ \$1,555,000. Match will be provided through Cleveland Metroparks and/or private funds.

#### No. 24-03-039:

#### (1) Change Order No. 1 – Contract No. 1729 – Cleveland Metroparks Garfield Pond Program Center, Garfield Park Reservation

(Originating Sources: Sean E. McDermott, P.E., Chief Planning and Design Officer/Seth Keller, Project Manager/Michele Crawford, Project Development Manager)

#### **Background**

On September 12, 2023 sealed bids were received for Bid #6782 Cleveland Metroparks Garfield Pond Program Center (the "Project"). On September 21, 2023, the Board of Park Commissioners awarded a contract to Schirmer Construction LLC ("Schirmer") as the lowest and best bidder for the Project in a not to exceed amount of \$1,856,000 (Board Resolution No. 23-09-149). At the time of the Board's award, only the building construction of the Program Center and adjoining patio was encompassed in the scope of work. Site utilities and the plaza were not yet designed or included in the bid documents. The Project includes one (1) new approximately 2,200 square foot building to serve as the hub for Cleveland Metroparks Youth Outdoors and Outdoor Experiences programming offered for youth fishing and "try it" watersports. The Project is adjacent to and will complement the current Garfield Pond and Stream Restoration project bringing back the former grandeur of Garfield Park.

On November 16, 2023, Cleveland Metroparks Board authorized the Chief Executive Officer to amend the Guaranteed Maximum Price (GMP) contract with Nerone & Sons, Inc. for construction of RFP #6520-b, Garfield Park Pond and Stream Restoration Project, to reflect GMP 6. Under the amendment GMP 6, work was included to perform Plaza Site Work as well as Site Utility work for the Program Center. As part of the recommendation for that work to now be performed by Schirmer as described herein, the related portions of the Nerone & Sons, Inc. GMP 6 will be non-performed.

#### Change Order No. 1

Since September, the construction of the Project has begun and is progressing as scheduled. The scope of work encompassed in Change Order No. 1 adds scope to the Project for the construction of the plaza site work as well as site utility work to be performed by Schirmer Construction. Change Order No. 1 also includes separate and additional items for the Program Center as listed below that require contract modifications:

## **BID RENEWAL #6526 SUMMARY:** PRE-EMPLOYMENT PHYSICALS, DRUG TESTING, AND VARIOUS EMPLOYMENT SCREENING

#### **Background**

Cleveland Metroparks currently obtains pre-employment physicals and drug testing (including nicotine), required Department of Transportation (DOT) random drug/alcohol testing for commercial driver license employees, random drug/alcohol testing for non-DOT employees, and reasonable suspicion and post-accident drug/alcohol testing. In addition, Cleveland Metroparks obtains Police Dive Team exams and TB tests for certain Zoo employees.

On December 18, 2020, Cleveland Metroparks released a bid for Pre-Employment Physicals, Drug Testing, and Various Employment Screening services, seeking a three (3) year term and an option to renew for an additional three (3) year term at Cleveland Metroparks sole discretion.

The bid was sourced to 22 vendors and Cleveland Metroparks received two (2) bids: Occupational Health Centers, DBA: Concentra Medical Centers and KK Alliance, DBA: USA Mobile Drug Testing.

Cleveland Metroparks has utilized Occupational Health Centers, DBA: Concentra Medical Centers since 2000 for all pre-employment physicals and drug testing, DOT random drug/alcohol testing, and for virtually all other random testing services. In addition, Concentra provides Third Party Administrator (TPA) services for random selection pools and Federal Motor Carrier Safety Administration (FMCSA) Clearinghouse compliance.

Cleveland Metroparks has utilized KK Alliance, DBA: USA Mobile Drug Testing since 2018 for onsite reasonable suspicion, post-accident, and certain scheduled drug and alcohol tests.

The Board approved a split award to Occupational Health Centers, DBA: Concentra Medical Centers and KK Alliance, DBA: USA Mobile Drug Testing as service providers for the initial three (3) year period from April 1, 2021 through March 31, 2024 (Resolution No. 21-03-037) with an option to renew Occupational Health Centers for an additional three (3) year period beginning April 1, 2024 through March 31, 2027.

The Purchasing Division recommends the renewal of contracted services from Occupational Health Centers, DBA: Concentra Medical Centers for an additional three (3) year period beginning April 1, 2024 through March 31, 2027.

#### **<u>RECOMMENDED ACTION</u>**:

That the Board authorize a three-year extension of the purchases set forth above on an "as needed basis" from Occupational Health Centers, DBA: Concentra Medical Centers, as per Bid Renewal #6526, for a three (3) year period, beginning April 1, 2024 through March 31, 2027, total cost not to exceed \$154,207 (as shown and at the unit prices reflected and on file in the Procurement Office), reflecting a total six-year cost not to exceed \$296,707, and, further, that the Board authorize the Chief Executive Officer to execute the Amendment to the Agreement for Medical Services in a form

approved by the Chief Legal & Ethics Officer. In the event the log of consumption approaches 90% of the total estimate, an action will be presented to the Board requesting an increase.

## **BID #6828 SUMMARY:** 2024 ASPHALT PATH IMPROVEMENTS – SENECA AND SHAWNEE HILLS GOLF COURSES

(Originating Sources: Joseph V. Roszak, Chief Operating Officer/Jim Rodstrom, Director of Construction)

Cleveland Metroparks Park Operations Department has taken inventory and condition assessments of degraded asphalt cart paths at all golf courses. Based on those assessments, cart paths at two locations were identified that warrant new asphalt. This improvement project includes the asphalt paving of approximately 9.3 miles total of existing cart paths.

The scope of work includes the following:

Asphalt overlay of approximately 13,035 total combined square yards of variable width existing asphalt cart path and approximately 37,311 total combined square yards of 9 foot wide full depth asphalt path on existing aggregate path. 48 square yards of butt-joint transition asphalt pavement planing and one catch basin adjusted to grade prior to paving operations.

Staff recommends awarding the bid to the lowest and best bidder, **Barbicas Construction Co.** Barbicas has performed as the prime contractor on the Park District's asphalt improvement program in 2016, 2017, 2018, 2019, and 2023. In addition, they have successfully completed similar projects for other northeast Ohio public agencies. They have completed approximately \$4.0 M in paving contracts for Cleveland Metroparks over the past several years and specialize in county, municipal, and commercial paving as well as ODOT projects.

## **<u>RECOMMENDED ACTION</u>**:

That the Board authorize the Chief Executive Officer to enter into a contract with **Barbicas Construction Co.** as the lowest and best bidder for Bid #6828, 2024 Asphalt Path Improvements, for the **total amount of \$1,026,518**. ## **BID #6830 SUMMARY:** SENECA GOLF COURSE GREENS DRAINAGE INSTALLATION, BRECKSVILLE RESERVATION

#### **Background**

Cleveland Metroparks released a bid for the Seneca Golf Course Greens Drainage Installation. The greens at Seneca Golf Course are clay based and do not allow for adequate drainage; rainfall will remain standing on the greens.

There are several greens at Seneca Golf Course (Chippewa #4, #6, #8, #9; Furnace Run #1, #2, #5, #8, #9; Baldwin #1, #2, #3, #4, #5) that continue to challenge staff with drainage issues.

Bidders were asked to layout the drainage system on six (6) foot spacing's, stripping of existing sod, slit trenching 14-16 inches deep with laser grade control and removal of exaction, installation of 2" c.p.t. (corrugated plastic tubing); includes all connections, backfill and compaction of trench profile with 60:20:20 sand organic USGA mix (Cleveland Metroparks will supply approximately 219 tons of fill), and replace sod.

Two (2) bids were received on February 20, 2024 and are tabulated below.

#### **Background**

Cleveland Metroparks implemented Shopify Inc. for its retail point of sale (POS) system in December 2022 pursuant to a 15-month contract in the sum of  $\pm$ \$65,000. Previously, Cleveland Metroparks Retail Division was utilizing three (3) separate POS systems: Yellow Dog (inventory management), Kentico (E-commerce), and Micros (point-of-sale). The difficulty of these systems included but was not limited to: (1) inability to be mobile (pop-up events), (2) high shipping rates, (3) software incompatibility issues, (4) slow to market, and (5) poor and highpriced technical support.

Shopify offers all three (3) services in one (1) platform and has solved numerous issues Retail was facing with prior systems. Cleveland Metroparks has utilized Shopify in the below locations, each with varying needs and capabilities:

- 1. North Chagrin Nature Shop Retail
- 2. Rocky River Nature Shop Retail
- 3. Hinckley Lake Boathouse Retail
- 4. Edgewater Beach Nature Shop Retail

Also, to reduce the number of POS systems used internally, Shopify has been implemented by Volunteer Services, and Cleveland Metroparks is currently examining whether to transfer Outdoor Education to Shopify, as well as hosting Cleveland Metroparks Zoo merchandise on our Shopify E-commerce platform.

## **Fees Overview**

Currently, Shopify Inc. is approximately  $\pm$ \$24,420 per year for platform fees. Shopify pricing is increasing to \$30,420 per year for platform fees. Shopify presented Cleveland Metroparks with the option to sign a three (3) year contract amendment to lock in current rates ( $\pm$ \$24,420 annually for platform fees), saving \$6,000 annually or \$18,000 over the next three (3) years.

Operating costs may fluctuate depending on several factors which include: (1) addition of apps which may add to our monthly fee, (2) shipping charges, (3) potential hardware needs over the next three years, and, (4) increase in orders.

## **INFORMATION/BRIEFING ITEMS/POLICY.**

#### (a) Cleveland Metroparks 2023 Real Estate Report

(Originating Sources: Brian M. Zimmerman, Chief Executive Officer/Rosalina M. Fini, Chief Legal & Ethics Officer/Kyle G. Baker, Director of Real Estate & Senior Assistant Legal Counsel/Stephanie A. Kutsko, Senior Real Estate Manager/Alexis E. Triozzi, Staff Attorney/Nathaniel M. Hoover, Land Conservation Manager/Gayle L. Albers, Conservation Stewardship Specialist/Dana L. Eppele, Real Estate Paralegal)

In 2023, Cleveland Metroparks acquired 499 acres in 20 transactions, bringing Cleveland Metroparks' total acreage to 25,204 acres. The 2023 acquisitions provided protection opportunities in 11 communities and 11 reservations, protecting forests, wetlands, and streams while creating new opportunities for recreation with additional trails and expanded connections. Cleveland Metroparks acquired \$21,473,400 in real estate, and Cleveland Metroparks provided 45 percent of the funding for that land value.

## **INFORMATION/BRIEFING ITEMS/POLICY** (cont.)

The land acquired in 2023 was largely acquired through donations and grants. Of the 499 acres, 339 acres were acquired with the assistance of grant funds or donated by individual landowners, local companies, school districts, municipalities, conservation partners, and community land banks. A substantial amount of the Cleveland Metroparks property acquisitions in 2023 were accomplished through partnerships. Two properties were acquired through improved relationships with our local land banks and four properties were acquired through our continued partnership with West Creek Conservancy, adding 101 acres to West Creek Reservation. Two additional properties were acquired from local municipalities expanding upon Gordon Park in Lakefront Reservation and Viaduct Park in Bedford Reservation. Cleveland Metroparks secured \$2,240,000 in outside funding from the Clean Ohio Conservation Fund, the North American Wetlands Conservation Act (NAWCA), and the City of Solon. These funds were spread across two properties in South Chagrin Reservation.

Cleveland Metroparks acquired two approximately 150-acre golf courses in 2023, adding Ironwood Golf Course to Hinckley Reservation and Hawthorne Valley Country Club to South Chagrin Reservation. Ironwood will continue to operate as a golf course and Hawthorne will be preserved, restored, and developed for recreational use. One key acquisition was the addition of the Grain Craft Property, which added 3.3 acres to the Columbus Road Peninsula just north of Rivergate Park. The acquisition of the Grain Craft property will allow Cleveland Metroparks to continue to plan for and implement a riverfront trail along the Cuyahoga River. In addition to acquiring nearly 500 acres, Cleveland Metroparks also acquired a floating barge, a unique opportunity that will be the future home of a lakefront nature center. The land acquired in 2023 brought Cleveland Metroparks total acreage to over 25,000 acres, adding over 1,000 acres in just three short years.
