Zimmerman, Chief Financial Officer, William Chorba, and Sr. Assistant Legal Counsel & Director of Real Estate, Kyle G. Baker, were also in attendance.

(a) *Swearing in of Patrol Officers* (Originating Source: Katherine M. Dolan, Chief of Police)

Kara A. Ditch

Kara Ditch joins the Cleveland Metroparks Police Department after graduating from Polaris Police Academy as the class Sergeant. Kara has a bachelor's degree in Criminal Justice from Ohio Northern University. Kara most recently worked part time with Cleveland Metroparks in park maintenance.

An explanation of adjustments, by category, can be found on pages <u>94004</u> to <u>94006</u>. The net effect of all adjustments is an increase of \$2,673,703, which is funded by increased revenue, donations, grants, or received but previously unappropriated restricted funds.

No. 21-07-091: It was moved by Vice President Rinker, seconded by Vice President Berry and carried, to approve the 2021 Budget Adjustment No. 7 for a total increase of \$2,673,703 as delineated on pages **<u>94004</u>** to **<u>94006</u>**.

(c) Ratification of Collective Bargaining Agreement with the Cleveland Metroparks Employees Association

(Originating Sources: Brian M. Zimmerman, Chief Executive Officer/Harold G. Harrison, Chief Human Resources Officer)

Two collective bargaining agreements have been negotiated with the Cleveland Metroparks Employees Association (CMEA). The first agreement is a one-year contract

extension from January 1, 2020 through December 31, 2020. This agreement contains no changes to the prior contract, including no wage increases.

The second agreement is for a three-year period from January 1, 2021 through December 31, 2023. This agreement contains wage increases, the payment of a health insurance rebate, and the addition of Juneteenth as a holiday.

A CMEA ratification meeting was held Thursday, July 1, 2021, with the membership ratifying both agreements.

The following is a summary of the financial impact of these agreements:

2020 – 0% wage increase

2021 - 3.5% wage increase and health insurance rebate

- 2022 2.5% wage increase
- 2023 2.5% wage increase (contingent upon passage of a new levy)

Cleveland Metroparks maintains the right to provide discretionary bonuses based on an employee's performance during the duration of the agreements. Health benefits premium contributions levels are maintained for the duration of the agreement (Plan A -18% / Plan B -13%), and Cleveland Metroparks will continue to incorporate a \$100.00 spousal surcharge.

No. 21-07-092: It was moved by Vice President Rinker, seconded by Vice President Berry and carried, to authorize the Chief Executive Officer to execute collective bargaining agreements, in a form approved by the Chief Legal and Ethics Officer and the Chief Human Resources Officer, with CMEA for 2020 and for the three-year period from January 1, 2021 through December 31, 2023.

(d) Authorization to Enter into Affiliate Agreement for Horseback Riding Event Center (Originating Sources: Brian M. Zimmerman, Chief Executive Officer/Rosalina M. Fini, Chief Legal & Ethics Officer/Joseph V. Roszak, Chief Operating Officer/Nancy Desmond, Special Projects Administrator/Katie M. McVoy, Assistant Legal Counsel)

Background

The Brecksville Stables occupy a portion of Brecksville Reservation located at 11921 Parkview Road in the City of Brecksville. In 2018, after deciding not to use the Stables for horse boarding, Cleveland Metroparks entered into a three-year pilot management

services program with Classical Attraction Dressage Society ("CADS") to operate a horseback riding event center, focused principally on dressage events.

CADS is a non-profit organization whose goal is to promote the advancement and sport of dressage in Northeast Ohio, as well as providing horsemanship education for riders of all ages, experience, and skill levels.

In the three years CADS has operated out of Brecksville Stables, it has hosted dozens of dressage events each year, including virtual events during the pandemic. CADS has proved a capable, responsible partner that has increased use of Brecksville Stables by bringing in contestants and the public for dressage events.

CADS has requested that Cleveland Metroparks enter into an affiliate agreement with CADS, similar to those Cleveland Metroparks has with other organizations aligned with Cleveland Metroparks' mission, including Lake Erie Nature & Science Center, BayARTS, the Foundry, and Crooked River Archers. As an affiliate, CADS would accept responsibility for the upkeep and maintenance of all buildings included in its license agreement, including two of the stables at Brecksville Stables, the equipment barn, outdoor arena, offices and indoor arena, and two paddocks. Cleveland Metroparks staff believes that CADS' mission aligns with that of Cleveland Metroparks, and that CADS would be a good affiliate and custodian of the Brecksville Stables.

Proposed CADS License Agreement

Cleveland Metroparks would like to enter into a license agreement with CADS to be a Cleveland Metroparks affiliate and operate Brecksville Stables as a horseback riding event center, with a focus on dressage.

Under the agreement, CADS will occupy a portion of Brecksville Stables, including using two of the stable barns, offices and indoor arena, two fenced outdoor paddocks, outside arena, and equipment barn. Cleveland Metroparks and CADS will have shared use of certain overflow parking and a paved turn-around located around the stables. Cleveland Metroparks will maintain control of the paved parking area near the stables and all bridle trails in the area. CADS welcomes continued use of all areas surrounding Brecksville Stables by Cleveland Metroparks visitors, including horseback riders.

No boarding will take place at Brecksville Stables. Instead, under the agreement, CADS will hold approximately thirty-six to forty-two events per year, including summer and winter dressage shows, dressage clinics, organized trail rides, and youth summer camps. The public will be welcome to participate in all CADS programs, whether as participants or spectators.

The term of the agreement shall be from August 1, 2021 through December 31, 2023. The Agreement shall be renewable in two-year increments at Cleveland Metroparks' discretion. As is the case with Cleveland Metroparks' other affiliate agreements, CADS will not pay a fixed rent, but will be responsible for maintaining the buildings and outdoor areas it occupies.

Note: David Crawford of CADS was present during the meeting and offered comments about the organization.

No. 21-07-093: It was moved by Vice President Rinker, seconded by Vice President Berry and carried, to authorize the Chief Executive Officer to enter into an agreement with Classical Attraction Dressage Society making CADS an affiliate and granting it a license to use identified areas of Brecksville Stables as a horseback riding events center from August 1, 2021 through December 31, 2023, with two-year renewal periods at Cleveland Metroparks' discretion. The agreement will be entered into a form approved by Cleveland Metroparks Chief Legal and Ethics Officer.

(e) *Authorization of Land Acquisition: Barnes Property, Brecksville Reservation (± 2.1 acres)*

(Originating Sources: Brian M. Zimmerman, Chief Executive Officer/Rosalina M. Fini, Chief Legal & Ethics Officer/Kyle G. Baker, Director of Real Estate & Senior Assistant Legal Counsel/Stephanie A. Kutsko, Real Estate Manager)

Cleveland Metroparks has the opportunity to acquire a parcel of land along the western side of Bennett Road and adjacent to Brecksville Reservation. The \pm 2.1-acre Barnes Property is located at 14774 Bennett Road (reference map, page **94007**) and adjacent to an all-purpose trail that runs along the western side of Bennett Road south to Akins Road. The City of North Royalton plans to construct another segment of trail from Akins Road south along Bennett Road to Cleveland Metroparks Brecksville Reservation and Valley Parkway. When complete, this all-purpose trail will provide a connection for park users from Royalton Road south to Brecksville Reservation and Valley Parkway, which links Cleveland Metroparks reservations, the Ohio & Erie Towpath Trail, the Cuyahoga Valley National Park, and serves as a local connection between neighborhoods, community resources, and employers.

In March of 2019, Cleveland Metroparks had the opportunity to accept a land donation from the City of North Royalton. The \pm 15.2-acre North Royalton property created a connection from Royalton Road southeast to Bennett Road. Simultaneously Cleveland Metroparks also acquired the 2.9-acre Rodriguez property on Bennett Road to provide increased access along Bennett Road. Preservation of the North Royalton and Rodriguez properties created an opportunity to create additional greenspace connectivity to park users of Brecksville Reservation and the community of North Royalton.

The acquisition of the Barnes Property along with the Rodriguez and North Royalton properties will create $a \pm 20$ acre preserve and enhance the trail connection along Bennett Road to Brecksville Reservation and the highly popular Valley Parkway. The acquisition of these properties will also protect the headwater streams and forests within the East Branch of the Rocky River watershed.

No. 21-07-094: It was moved by Vice President Rinker, seconded by Vice President Berry and carried, to authorize the acquisition of fee simple title of \pm 2.1 acres as hereinabove described, from Bella Katrina Johnson and Maria J. Barnes, for a purchase price of \$185,000 subject to the approval of the environmental assessment report and evidence of title, including exceptions to title, by the Chief Legal and Ethics Officer; further, that the Board authorize the Chief Executive Officer to execute agreements or documents, together with supplemental instruments related thereon, if any, as deemed necessary or appropriate and in form acceptable to the Chief Legal & Ethics Officer.

(f) Zoo Community Engagement Project – Collaboration Agreement (Originating Sources: Christopher Kuhar, Zoo Executive Director/Kristen Lukas, Director of Conservation and Science)

Background

One of the biggest challenges in building a global conservation program is providing the best value proposition to the citizens of northeast Ohio. In an effort to create that value proposition, Cleveland Metroparks Zoo is partnering with faculty at Antioch University – New England to create a community engagement project to determine the most valuable aspects of our programs to the community.

The project will be coordinated by faculty and graduate students at Antioch University. These core personnel will provide the leadership and management of the VISTA (Volunteers in Service to America) members, as well as coaching sessions to develop the skills of these VISTA members. Total operational responsibilities include daily management of the project and project staff, coaching of staff, and the production of an annual report for the project.

Cleveland Metroparks Zoo will provide funds to support this operation in the amount of \$89,175 over a three-year period.

As a result of the services provided by Antioch University and in collaboration with our neighbors and local organizations in Old Brooklyn, Brooklyn Centre, Stockyards, Clark-Fulton, Tremont, Ohio City and Detroit Shoreway, we will identify current community needs as well as existing community strengths and resources. With the Zoo's conservation mission in mind, we will then work together to design relevant conservation programming that builds on these existing neighborhood assets and helps to meet community needs and aspirations.

Objectives and outcomes for the three years of the project have been defined by Antioch University and Cleveland Metroparks Zoo with the goal of increasing participation in and support of the Zoo's conservation programs to benefit the members of the communities nearest the Zoo.

<u>No. 21-07-095</u>:

It was moved by Vice President Rinker, seconded by Vice President Berry and carried, to authorize the Chief Executive Officer to enter into an agreement, in a form approved by the Chief Legal & Ethics Officer, between Cleveland Metroparks and **Antioch University** for a three-year period effective July 15, 2021 through June 30, 2024 to fund management services for the community engagement project in an **amount not to exceed \$89,175**, as specified above.

(g) Authorization for Cleveland Metroparks Police Department to Enter into Intergovernmental Cooperative/Mutual Aid Agreements

(Originating Sources: Katherine Dolan, Chief of Police/Kenneth Schabitzer, Captain/Rosalina M. Fini, Chief Legal & Ethics Officer)

Background

The City of Cleveland and the Village of Cuyahoga Heights and Cleveland Metroparks share a mutual concern to provide a safe and secure environment throughout the city, village, and the Park District. Ohio Revised Code §1545.131 provides authority for a park district to enter into agreements with municipal corporations and villages to assist with police protection. The interagency agreements will delineate requests for assistance, Cleveland Metroparks' responsibilities, the respective city and village responsibilities, and other relevant terms. Cleveland Metroparks has previously entered into a mutual aid agreement with the City of Cleveland for the Lakefront Reservation. This new mutual aid agreement with the City of Cleveland will include the complete Cleveland Metroparks' jurisdiction.

No. 21-07-096: It was moved by Vice President Rinker, seconded by Vice President Berry and carried, to authorize the Cleveland Metroparks Chief Executive Officer to enter into an Intergovernmental Cooperative/Mutual Aid Agreement with both the City of Cleveland and Village of Cuyahoga Heights in a form to be approved by the Chief Legal & Ethics Officer.

(h) Adoption of Revised Cleveland Metroparks Codified Rules and Regulations – 2021 (Originating Sources: Brian M. Zimmerman, Chief Executive Officer/Rosalina M. Fini, Chief Legal & Ethics Officer/Katherine Dolan, Chief of Police/Anne Eisenhower, Chief Prosecuting Attorney /Joseph Roszak, Chief Operating Officer/Robert Butler, Captain/Ken Schabitzer, Captain)

Note: Chief Executive Officer, Brian M. Zimmerman, removed this item from the agenda and it was deferred to a future date.

Background

Pursuant to Article 1, Section 1 of the Board of Park Commissioners of the Cleveland Metropolitan Park District By-Laws, the Park District's Codified Rules and Regulations must be amended to ensure conformity with State and Federal law and address other public policy issues. In this review, the following modifications are hereby proposed:

- <u>General Required Changes</u>: Several changes occurred to the Ohio Revised Code and require the Board of Park Commissioners to further update its Codified Rules and Regulations as recommended by the Walter H. Drane Company, who annually performs the comprehensive code revisions for Cleveland Metroparks. A Summary of Changes to Traffic and General Offenses Codes for 2021, is provided on page <u>94008</u>.
- 2. <u>Additional Changes to Regulations</u>: After review of the Codified Rules and Regulations, the following changes are proposed by staff. The proposed new language is underlined and proposed language to be removed is stricken as noted below.

A. Part 3 Traffic Code

1) Throughout Part 3, replace "scooter" with "micromobility device."

2) BICYCLE; MOTORIZED BICYCLE; MOPED.

301.04(g) "Scooter" means any vehicle having either two or four tandem wheels, that may be pushed forward with foot motion, and that is equipped with a helper motor of not more than fifty cubic centimeters piston displacement that produces not more than one brake horsepower and is capable of propelling the vehicle at a speed of not greater than twenty miles per hour on a level surface.

373.01 CODE APPLICATION TO BICYCLES.

(a) Bicycles, electric bicycles and <u>micromobility device</u> are only permitted upon roadways, all purpose trails, and other paths designated for the use of bicycles, and the provisions of this Traffic Code which are applicable to bicycles, electric bicycles and <u>micromobility devices</u> shall then apply whenever a bicycle, electric bicycles and <u>micromobility device</u> is operated.

(1) The operation of a class 1 electric bicycle, a class 2 electric bicycle and <u>micromobility device</u> is permitted on a path set aside for the exclusive use of bicycles or on a shared-use path including the all purpose trail (APT);

(2) No person shall operate a class 3 electric bicycle on a path set aside for the all purpose trails, other paths designated for the use of bicycles, or a shared use path.

- i. No person under sixteen years of age shall operate a class 3 electric bicycle; however, a person under sixteen years of age may ride as a passenger on a class 3 electric bicycle that is designed to accommodate passengers.
- ii. No person shall operate or be a passenger on a class 3 electric bicycle unless the person is wearing a protective helmet that meets the standards established by the Consumer Product Safety Commission or the American Society for Testing and Materials.

(3) No person shall operate a class 1 electric bicycle, a class 2 electric bicycle, a class 3 electric bicycle, or a <u>micromobility device</u> on a path that is intended to be used primarily for mountain biking, hiking, equestrian use, or other similar uses, or any other single track or natural surface trail that has historically been reserved for nonmotorized use.

(4) Subsections (a)(2) and (a)(3) of this section do not apply to a law enforcement officer, or other person sworn to enforce the criminal and traffic laws of the state, using an electric bicycle while in the performance of the officer's duties.

373.11 LOW-SPEED MICROMOBILITY DEVICES.

- (a) (1) Except as otherwise provided in this section, those sections of this title that by their nature could apply to a low-speed micromobility device do apply to the device and the person operating it whenever it is operated upon any public street, highway, sidewalk, or shared-use path, or upon any portion of a roadway set aside for the exclusive use of bicycles.
- (b) No operator of a low-speed micromobility device shall do any of the following:
 - (1) Fail to yield the right-of-way to all pedestrians at all times;

(2) Fail to give an audible signal before overtaking and passing a pedestrian;

(3) Operate the device at night unless the device or its operator is equipped with or wearing both of the following:

A. A lamp pointing to the front that emits a white light visible from a distance of not less than 500 feet;

B. A red reflector facing the rear that is visible from all distances from 100 feet to 600 feet when directly in front of lawful lower beams of head lamps on a motor vehicle.

(c) (1) No person who is under sixteen years of age shall rent a low-speed micromobility device.

(2) No person shall knowingly rent a low-speed micromobility device to a person who is under sixteen years of age.

(3) No person shall knowingly rent a low-speed micromobility device on behalf of a person who is under sixteen years of age.

- (d) No person shall operate a low-speed micromobility device at a speed greater than twenty miles per hour.
- (e) (1) Whoever violates this section is guilty of a minor misdemeanor.
 (2) Unless a mens rea is otherwise specified in this section, an offense established under this section is a strict liability offense and Ohio R.C.
 2901.20 does not apply. The designation of that offense as a strict liability

offense shall not be construed to imply that any other offense, for which there is no specified degree of culpability, is not a strict liability offense.

(f) The owner or operator of a low-speed micromobility device rental service or low-speed micromobility device sharing program shall maintain commercial general liability insurance related to the operation of the devices, with limits of up to one million dollars (\$1,000,000) per occurrence and two million dollars (\$2,000,000) per aggregate. (ORC 4511.514)

1.) 505.01 PROHIBITED HOUSEHOLD PETS; CONTROL OF PETS.

(c) The running at large of any such animal in or upon park district property is prima-facie evidence that it is running at large in violation of this section <u>and</u> <u>a person's failure to control any such animal as evidenced by the animal</u> <u>biting a person, other than the owner, or biting another animal is prima-facie</u> <u>evidence of the failure to control the pet in violation of this section.</u>

(a) Trails Division Construction Update

(Originating Sources: Joseph V. Roszak, Chief Operating Officer/Jim Rodstrom, Director of Construction/Ralph Protano, Trails Development Manager)

With the 2021 construction season underway, Cleveland Metroparks Trails Division is in full swing with efforts on multiple fronts in relation to natural surface trails. These current initiatives are increasing production while showcasing some of their most technically advanced projects to date. In addition, the trail volunteer program and the utilization of conservation crews, student work crews, and trail construction contractors has allowed the division to expand its impact of the natural surface trail network across the Park District. Providing guest-focused trail experiences with an emphasis on natural resource protection continues to drive the direction of the division and trail development throughout Cleveland Metroparks.

(b) Acacia Clubhouse Condition Assessment

(Originating Source: Sean E. McDermott, P.E., Chief Planning and Design Officer)

Acacia Reservation, with its 156 acres and nearly 2 miles of all-purpose trail, was incorporated into the Park District in 2012 as the 17th reservation. The former country club property has been transformed and natural systems and functions restored along Euclid Creek, its wetland tributaries, and the upland woodlands throughout the park. Several structures have already been razed throughout the property as restoration projects have taken place. Currently the former cart barn is undergoing renovations to add accessible restrooms and reservable picnic space for park guests.

Since April of 2013, the noteworthy clubhouse on site has been operated by Dino's Catering via management services agreement. With the approaching expiration of the agreement on December 31, 2021, staff will provide information to the Board relative to the challenges of the continuance of operation of the clubhouse and will provide a succinct condition and utility consumption assessment.

Terri has exemplified the core values of Cleveland Metroparks throughout her career, and the products of her labor are appreciated and will forever serve generations of future Cleveland Metroparks employees and visitors.

Sean P. McHugh, Executive Director of Golf Operations

Sean McHugh served Cleveland Metroparks for 24 years. He devoted these years of service utilizing his knowledge, skills and abilities as Chief Superintendent of Golf Turf, Director of Golf Turf, and Executive Director of Golf Operations. Sean oversaw and managed golf turf and clubhouse operations to assure high-quality golf facilities for public use and enjoyment and assured a high level of maintenance and customer service to provide for a quality visitor experience, with Manakiki and Sleepy Hollow consistently ranked in Golfweek's Best Public Courses. He assisted with the facilitation, planning and opening of Washington golf course, a 9-hole golf course and driving range which was successfully planned to comply with the Audubon International's Cooperative Sanctuary Program and oversaw significant renovations at Seneca golf course. Additionally, he led the golf department successfully through the challenges of the Coronavirus pandemic achieving record high usage of Cleveland Metroparks eight golf course renovations drew new and returning golfers. Sean's dedication has been an asset to Cleveland Metroparks, and we thank him for his service.

Richard Svoboda, Police Captain

Richard Svoboda served Cleveland Metroparks for more than 32 years. Rich's commitment and hard work have been appreciated by the Police Department and will not be forgotten.

Paul W. Wakefield, Senior Technician

(c) State of Ohio Authorized Services #6597: Authorization to Enter into Contract Amendment with an Audit Firm for Cleveland Metroparks Annual Financial Audits for the Years 2021-2025

(Originating Source: William Chorba, Chief Financial Officer)

Background

The Ohio Revised Code (ORC) 4701.19 requires that the Ohio Auditor of State perform an annual financial audit of all Public Offices. The ORC further provides that when the Ohio Auditor of State determines it cannot audit a Public Office, it shall engage the services of an Independent Public Accountant (IPA) to perform the financial audit, with the IPA's fees to be paid by the Public Office.

In 2016, the Ohio Auditor of State solicited proposals from various accounting firms to conduct Cleveland Metroparks' annual audit. The proposals were evaluated and awarded by the Ohio Auditor of State, based on the following categories:

- 1. Timeliness of the proposal submission
- 2. Quality of prior audit reports filed with the Ohio Auditor of State
- 3. Quality of workpapers reviewed by the Ohio Auditor of State from prior audits
- 4. Any backlog of current audits
- 5. Understanding of the scope of the audit
- 6. Experience, expertise, and training of the firm
- 7. Qualified MBE Firm
- 8. Cost of the proposal

The Ohio Auditor of State authorized an award to Clark, Schaefer, Hackett & Company for an initial term of five (5) years, beginning with the audit for the year ending December 31, 2016.

Cleveland Metroparks was notified by the Ohio Auditor of State that, due to scheduling constraints, it would extend the contract with Clark, Schaefer, Hackett & Company for Cleveland Metroparks' annual financial audits for an additional five (5) years.

Recommendation

Cleveland Metroparks Finance staff recommends a contract extension with the Ohio Auditor of State and Clark, Schaefer, Hackett & Company for an additional five (5) year

period beginning with the audit for the year ending December 31, 2021 through the time required for the audit for the year ending December 31, 2025 for \pm the following prices:

The total cost of the contract, which may include additional hourly charges if necessary, shall not exceed One Hundred Fifty Thousand Dollars (\$150,000).

<u>RECOMMENDED ACTION</u>:

That the Board authorize the Chief Executive Officer to enter into an agreement as specified in State of Ohio Authorized Services #6597 with the Ohio Auditor of State and Clark, Schaefer, Hackett & Company to conduct annual financial audits for a five (5) year agreement and contract extension beginning with the audit for the year ending December 31, 2021 through the audit for the year ending December 31, 2025 for a total cost not to exceed \$150,000. The agreement will be entered into a form approved by Cleveland Metroparks Chief Legal and Ethics Officer.

(d) Ohio and Erie Canal and Rocky River Reservations: Authorization to Submit Grant Applications and Commit Funds

(Originating Sources: Sean McDermott, Chief Planning and Design Officer/Natalie Ronayne, Chief Development Officer/Rosalina M. Fini, Chief Legal & Ethics Officer/Kyle G. Baker, Director Real Estate/Stephanie Kutsko, Real Estate Manager/Sara Byrnes Maier, Senior Strategic Park Planner/Kristen Trolio, Grants Manager)

The Outdoor Recreation Legacy Partnership (ORLP) Program provides funds to acquire and/or develop land for outdoor recreation. The program funds projects in designated "Urbanized Areas" as defined by the U.S. Census Bureau. The program is funded by the National Park Service and in the State of Ohio, the program is administered by the Ohio Department of Natural Resources (ODNR).

Cleveland Metroparks has submitted two applications to ODNR for their review, approval, and subsequent submittal to the National Park Service for the competitive grants program: Cleveland Flats Rivergate Park Expansion and Hogsback Lane Connector Trail.

Hogsback Lane

Cleveland Metroparks requests funds to design, engineer, and construct a $\pm 2,220$ f allpurpose trail along Hogsback Lane in Rocky River Reservation. Hogsback Lane is a 22'-wide paved roadway that runs northeast-southwest and connects Riverside Drive and

Valley Parkway (reference map, page <u>51</u>). The roadway is located in the City of Cleveland near the confluence of the Cities of Cleveland, Lakewood, and Fairview Park, and is a year-round roadway that is maintained by Cleveland Metroparks with vehicle counts over 375,000 annually. The roadway serves as a connection between the southern neighborhoods in the City of Lakewood, the West Park Neighborhood in the City of Cleveland, and Valley Parkway in Rocky River Reservation.

The grade of Hogback Lane exceeds 5% and the existing narrow roadway offers no safe pedestrian connection. The proposed paved all-purpose Hogsback Lane Connector trail will be constructed alongside the existing roadway, which will be widened to 24' and will remain as a public roadway maintained by Cleveland Metroparks. A paved all-purpose trail along Hogsback Lane has been identified as a need for Rocky River Reservation for 14+ years to meet the needs of park patrons and to fulfill the Park District's goal of connecting communities to parkland.

The project costs are as follows:

Cleveland Flats Rivergate Park Expansion

Cleveland Metroparks requests funds to acquire and restore ± 1.1 acres (PPNS 101-16-001, 002, 019 and 020) currently owned by Marlin Investment Group, LLC located at 1600 Merwin Avenue in the City of Cleveland ("Marlin Property") near Heritage and Rivergate Parks (reference map, page <u>52</u>). The Marlin Property is currently operated as Catanese Classics, a wholesale and retail seafood company, which plans to relocate and has signed a Letter of Intent to sell to Cleveland Metroparks.

The Marlin Property is located directly on the Cuyahoga River ship channel on the Columbus Road Peninsula in the industrial Flats area and contains \pm 300lf of riverfront. Cleveland Metroparks seeks to restore the Marlin Property to public greenspace. Cleveland Metroparks developed a preliminary site plan which indicates a new parking area for access, open greenspace along the riverfront, and trail connections. Acquisition of the Marlin Property will add to the recreation hub on the Columbus Road Peninsula, including Rivergate Park, Heritage Park, the City of Cleveland's Crooked River Skate Park, the Foundry, and the Cleveland Rowing Foundation.

The total project costs (including land acquisition and development) are as follows:

<u>RECOMMENDED ACTION</u>:

That the Board approve the adoption of the resolutions to authorize the submittal of two grant applications to the Ohio Department of Natural Resources for funding assistance in the amounts of, and not exceeding, \pm \$2,142,717 and \pm \$2,618,750 through the Outdoor Recreation Legacy Partnership program as described above; to authorize and agree to obligate the required matching funds as described above and all funds required to satisfactorily complete the proposed projects and become eligible for reimbursement under the terms and conditions of the program; and further, that the Board authorize the Chief Executive Officer to enter into agreements and execute any other documents as may be required to accept the grants upon award; form of document(s) to be approved by Chief Legal and Ethics Officer.

(e) Authorization of Land Acquisition: Styles Property, Big Creek Reservation (± 2.3 acres)

(Originating Sources: Brian M. Zimmerman, Chief Executive Officer/Rosalina M. Fini, Chief Legal & Ethics Officer/Kyle G. Baker, Director of Real Estate & Senior Assistant Legal Counsel/Stephanie A. Kutsko, Real Estate Manager)

Cleveland Metroparks has the opportunity to acquire a \pm 2.3-acre property located at 18248 Fowles Road in the City of Middleburg Heights (the "Styles Property") and adjacent to Big Creek Reservation (reference map, page <u>55</u>). In 2015, Cleveland Metroparks acquired a 2.7-acre property, the Meincke Property, to the north of the Styles Property to buffer the Lake-to-Lake Trail in Big Creek Reservation ("Trail") and provide additional protection of the sensitive aquatic habitats of the Fowles Wetland area. The Trail is a universally accessible all-purpose trail and is a highlight of the reservation. The Trail travels through headwater wetlands and connects Lake Abram and Lake Isaac, the largest kettle lakes in Cuyahoga County.

Cleveland Metroparks has the opportunity to acquire the Styles Property in fee simple title as Kathleen J. Styles recently listed the property for sale. She has agreed to sell the property via fee simple title for \$190,000. The acquisition will provide a buffer to the Trail and a more welcoming trail experience as visitors enter the Trail from Fowles Road.

<u>RECOMMENDED ACTION</u>:

That the Board authorize the acquisition of fee simple title of ± 2.3 acres as hereinabove described, from Kathleen J. Styles for a purchase price of \$190,000 subject to the approval of the environmental assessment report and evidence of title, including exceptions to title, by the Chief Legal and Ethics Officer; further, that the Board authorize the Chief Executive Officer to execute agreements, together with supplemental instruments related thereon, if any, as deemed necessary or appropriate and in form acceptable to the Chief Legal & Ethics Officer.

(f) Authorization of Land Acquisition: Flats Industrial Railroad Company Property (± 1.0 acre) – Lakefront Reservation

(Originating Sources: Brian M. Zimmerman, Chief Executive Officer/Rosalina M. Fini, Chief Legal & Ethics Officer/Kyle G. Baker, Director of Real Estate & Senior Assistant Legal Counsel/Stephanie A. Kutsko, Real Estate Manager)

In 2012, Cleveland Metroparks invested in creating Rivergate Park, a public park along the Cuyahoga River providing scenic views, recreational opportunities, and a new emphasis on Cleveland's riverfront. In 2014, Merwin's Wharf became established as a place to enjoy freshly prepared food in a unique setting within the Cleveland Metroparks. Also in 2014, the City of Cleveland and Cleveland Metroparks entered into long-term leases to facilitate the best public use of the green space at Rivergate Park. Cleveland Metroparks leased to the City the northern triangular piece of land for the City's Crooked River Skatepark and the City leased to Cleveland Metroparks the frontage parcel along the Cuyahoga River adjacent to Merwin's Wharf. Cleveland Metroparks continued to improve public access, trail connections and greenspace along the Cuyahoga River by accepting a donation of a \pm 0.2-acre parcel of land from Flats Industrial Railroad Company ("Flats Industrial"), with the intention to utilize the 25-foot strip of land to extend a future trail from Rivergate Park to British Street.

As Rivergate Park continues to expand and recent trail connections have been completed, including the Red Line Greenway, Cleveland Foundation Centennial Trail, and Towpath Trail, Cleveland Metroparks continues to explore opportunities for growth on the Columbus Road peninsula. Cleveland Metroparks has again engaged with the Flats Industrial to inquire about purchasing ± 1.0 -acre of land adjacent to the ± 0.2 -acre parcel of land acquired in 2016. This ± 1.0 -acre ("Flats Property") is located south of British Street and west of Columbus Road in the City of Cleveland and adjacent to Rivergate Park and the Crooked River Skatepark (reference map, page <u>56</u>).

The Flats Property offers the opportunity to buffer the existing 25-foot strip of Cleveland Metroparks land by adding an additional \pm 1.0-acre of greenspace, creating a better connection opportunity to British Street and more greenspace for an improved trail experience. The industrial nature of the Flats Property also offers the opportunity to restore the area to a natural condition, creating a high-quality park in a space that is currently barren vacant land.

Flats Industrial has agreed to sell the \pm 1.0-acre property via fee simple title for \$1,000,000. Cleveland Metroparks will work to secure grant funding to help fund the acquisition, and the acquisition will be contingent upon being awarded such funds. Staff will come back to the Board to finalize the grant application(s) in the coming months and is exploring other partnerships to help preserve the Flats Property. Preservation of the Flats Property would be an invaluable addition to Rivergate Park and the associated trail connections to the Columbus Road peninsula.

<u>RECOMMENDED ACTION</u>:

That the Board authorize the acquisition of fee simple title of \pm 1.0 acre as hereinabove described, from the Flats Industrial Railroad Company, for a purchase price of \$1,000,000, contingent upon funding subject to the terms and conditions hereinabove summarized, and subject to the approval of the environmental assessment report and evidence of title, including exceptions to title, by the Chief Legal and Ethics Officer; further, that the Board authorize the Chief Executive Officer to execute agreements, together with supplemental instruments related thereon, if any, as deemed necessary or appropriate and in form acceptable to the Chief Legal & Ethics Officer.

(g) Authorization for Cleveland Metroparks Police Department to Enter into Intergovernmental Cooperative/Mutual Aid Agreement

(Originating Sources: Katherine Dolan, Chief of Police/Kenneth Schabitzer, Captain/Rosalina M. Fini, Chief Legal & Ethics Officer)

Background

The Village of Mayfield Village and Cleveland Metroparks share mutual concerns to provide safe and secure environments throughout the Village and the Park District. Ohio Revised Code §1545.131 provides authority for a park district to enter into agreements with municipal corporations and villages to assist with police protection. The interagency agreement will delineate requests for assistance, Cleveland Metroparks' responsibilities, the respective village responsibilities and other relevant terms.

<u>RECOMMENDED ACTION</u>:

That the Board authorize the Cleveland Metroparks Chief Executive Officer to enter into an Intergovernmental Cooperative/Mutual Aid Agreement with the Village of Mayfield in a form to be approved by the Chief Legal & Ethics Officer.

(h) Adoption of Revised Cleveland Metroparks Codified Rules and Regulations – 2021 (Originating Sources: Brian M. Zimmerman, Chief Executive Officer/Rosalina M. Fini, Chief Legal & Ethics Officer/Katherine Dolan, Chief of Police/Anne Eisenhower, Chief Prosecuting Attorney /Joseph Roszak, Chief Operating Officer/Robert Butler, Captain/Ken Schabitzer, Captain)

Background

Pursuant to Article 1, Section 1 of the Board of Park Commissioners of the Cleveland Metropolitan Park District By-Laws, the Park District's Codified Rules and Regulations must be amended to ensure conformity with State and Federal law and address other public policy issues. In this review, the following modifications are hereby proposed:

1. <u>General Required Changes</u>: Several changes occurred to the Ohio Revised Code and require the Board of Park Commissioners to further update its Codified Rules and Regulations as recommended by the Walter H. Drane Company, who annually performs the comprehensive code revisions for Cleveland Metroparks.

A Summary of Changes to Traffic and General Offenses Codes for 2021 is provided on page <u>57</u>.

2. <u>Additional Changes to Regulations</u>: After review of the Codified Rules and Regulations, the following changes are proposed by staff. The proposed new language is underlined and proposed language to be removed is stricken as noted below.

A. Part 3 Traffic Code

1) Throughout Part 3, replace "scooter" with "micromobility device."

2) BICYCLE; MOTORIZED BICYCLE; MOPED.

301.04(g) "Scooter" means any vehicle having either two or four tandem wheels, that may be pushed forward with foot motion, and that is equipped with a helper motor of not more than fifty cubic centimeters piston displacement that produces not more than one brake horsepower and is capable of propelling the vehicle at a speed of not greater than twenty miles per hour on a level surface.

373.01 CODE APPLICATION TO BICYCLES.

(a) Bicycles, electric bicycles and <u>micromobility devices</u> are only permitted upon roadways, all purpose trails, and other paths designated for the use of bicycles, and the provisions of this Traffic Code which are applicable to bicycles, electric bicycles and <u>micromobility devices</u> shall then apply whenever a bicycle, electric bicycles and/or <u>micromobility device</u> is operated.

(1) The operation of a class 1 electric bicycle, a class 2 electric bicycle and <u>micromobility device</u> is permitted on a path set aside for the exclusive use of bicycles, <u>including mountain bike trails</u>, or on a shared-use path including the all purpose trail (APT);

(2) No person shall operate a class 3 electric bicycle on a path set aside for the all purpose trails, other paths designated for the use of bicycles, or a shared use path.

- i. No person under sixteen years of age shall operate a class 3 electric bicycle; however, a person under sixteen years of age may ride as a passenger on a class 3 electric bicycle that is designed to accommodate passengers.
- ii. No person shall operate or be a passenger on a class 3 electric bicycle unless the person is wearing a protective helmet that meets the standards established by the Consumer Product Safety Commission or the American Society for Testing and Materials.

(3) No person shall operate a class 1 electric bicycle, a class 2 electric bicycle, a class 3 electric bicycle, or a <u>micromobility device</u> on a path that is intended to be used primarily for mountain biking, hiking, equestrian use, or

other similar uses, or any other single track or natural surface trail that has historically been reserved for nonmotorized use.

(4) Subsections (a)(2) and (a)(3) of this section do not apply to a law enforcement officer, or other person sworn to enforce the criminal and traffic laws of the state, using an electric bicycle while in the performance of the officer's duties.

373.11 LOW-SPEED MICROMOBILITY DEVICES.

- (a) (1) Except as otherwise provided in this section, those sections of this title that by their nature could apply to a low-speed micromobility device do apply to the device and the person operating it whenever it is operated upon any public street, highway, sidewalk, or shared-use path, or upon any portion of a roadway set aside for the exclusive use of bicycles.
- (b) No operator of a low-speed micromobility device shall do any of the following:

(1) Fail to yield the right-of-way to all pedestrians at all times;

(2) Fail to give an audible signal before overtaking and passing a pedestrian;

(3) Operate the device at night unless the device or its operator is equipped with or wearing both of the following:

A. A lamp pointing to the front that emits a white light visible from a distance of not less than 500 feet;

B. A red reflector facing the rear that is visible from all distances from 100 feet to 600 feet when directly in front of lawful lower beams of head lamps on a motor vehicle.

- (c) (1) No person who is under sixteen years of age shall rent a low-speed micromobility device.
 (2) No person shall knowingly rent a low-speed micromobility device to a person who is under sixteen years of age.
 (3) No person shall knowingly rent a low-speed micromobility device on behalf of a person who is under sixteen years of age.
- (d) No person shall operate a low-speed micromobility device at a speed greater than twenty miles per hour.
- (e) (1) Whoever violates this section is guilty of a minor misdemeanor.
 (2) Unless a mens rea is otherwise specified in this section, an offense established under this section is a strict liability offense and Ohio R.C.
 2901.20 does not apply. The designation of that offense as a strict liability offense shall not be construed to imply that any other offense, for which there is no specified degree of culpability, is not a strict liability offense.

(f) The owner or operator of a low-speed micromobility device rental service or low-speed micromobility device sharing program shall maintain commercial general liability insurance related to the operation of the devices, with limits of up to one million dollars (\$1,000,000) per occurrence and two million dollars (\$2,000,000) per aggregate. (ORC 4511.514)

B. Part 5 General Offenses Code

- 1.) 505.01 PROHIBITED HOUSEHOLD PETS; CONTROL OF PETS.
- (c) The running at large of any such animal in or upon park district property is prima-facie evidence that it is running at large in violation of this section and a person's failure to control any such animal as evidenced by the animal biting a person, other than the owner, or biting another animal is prima-facie evidence of the failure to control the pet in violation of this section.

(i) Contract Amendment 1553 – Heritage 1 and Rivergate Park Boat Slips – Construction Manager at Risk – Guaranteed Maximum Price 1

Background

On July 16, 2020, Cleveland Metroparks advertised for a Request for Qualifications (RFQu #6502) for firms to submit qualifications for the construction management (at risk) of the Heritage 1 and Rivergate Park Boat Slips ("Project"). As presented to the Board on October 15, 2020, the Project includes adding boat docks to Heritage 1 and Rivergate parks.

On October 15, 2020, the Board awarded a Construction Manager at Risk Contract to Schirmer Construction LLC ("Schirmer") for the Project. At the time of the Board's award, only the preconstruction stage compensation was fixed at \$19,000. Per the contract, a Guaranteed Maximum Price (GMP) for construction is then developed and brought back to the Board for approval.

Since October 2020, the design of the Project has advanced allowing for a phased GMP approach. The Project's design is currently solidifying and can benefit from data collected following a targeted removal of infrastructure as reflected below. The first phase of the GMP pricing for the Project includes the site clearing, demolition, deconstruction, temporary fencing, and salvaging operations related to the deck structure at Heritage Park 1.

Staff will return to the Board with Guaranteed Maximum Price 2 ("GMP 2") which will include the balance of costs related to the Project. GMP 2 will include, but is not limited to, docking, gangways, flatwork, walkways, railing, plumbing, electrical, and landscaping.

Construction Schedule

Schirmer's construction schedule associated with the proposed GMP 1 anticipates a spring 2022 project delivery barring any unseasonal weather delays or material procurement delays. Cleveland Metroparks staff will monitor construction progress and provide updates to the Board.

That the Board authorize the Chief Executive Officer to amend the Guaranteed Maximum Price (GMP) contract with Schirmer Construction LLC for the construction of RFP-b #6502, the Heritage 1 and Rivergate Park Boat Slips, to reflect a GMP 1 in the amount of \$232,728.28, which will be an amount in addition to the \$19,000 already awarded for preconstruction services, for a total contract value of \$251,728.28, in a form to be approved by the Chief Legal and Ethics Officer.

(j) Contract Amendment 1558 – Construction Manager at Risk for Cleveland Metroparks Garfield Park Pond and Stream Restoration Project – Garfield Park Reservation – Construction Guaranteed Maximum Price 1

Background

On November 19, 2020, Cleveland Metroparks awarded a Guaranteed Maximum Price (GMP) contract to Nerone & Sons, Inc. (Nerone) for Construction Manager at Risk services, as per RFP #6520-b, for the construction of the Garfield Park Pond and Stream

Restoration Project ("Project"). At the time of Board's approval, only the preconstruction stage compensation was awarded at \$11,000. Per the contract, a GMP for construction is then developed and brought back to the Board for approval.

The Project is funded through notable philanthropic and governmental grants. Funds are complemented using current and future Stormwater Management Reimbursement Funds established between Cleveland Metroparks and the Northeast Ohio Sewer District. Additional funding for construction is provided by Ohio Environmental Protection Agency 319(h) Grant. As a Project Partner, West Creek Conservancy is contributing to the grant education and outreach deliverables.

GPD Group and sub-consultant EnviroScience were awarded contract on August 20, 2020 to provide construction documents and permitting for the Project. Since then, they have advanced design and submitted necessary permit applications. The Project will reveal the former grandeur of the park by restoring Wolf Creek and re-establishing an offline lower pond. The area will serve as the hub for Cleveland Metroparks Youth Outdoors and Outdoor Experiences programs. Located adjacent to the Project area, programming will be offered for youth fishing and 'Try It' watersports including kayaking, fishing, and standup paddle boarding. Trails, fishing piers, kayak launches, meeting areas and a new recreation building will be integrated into the restoration of this natural area.

As a first step towards completing this work, select trees throughout the Project area will be removed for pond restoration, streambank grading and re-alignment of Wolf Creek. Additionally, trees will be felled and limbed and grubbing and underbrush clearing will occur to improve visibility throughout the Project area. Removed trees will be integrated into the restoration to provide habitat. Hardwood trees will be processed and integrated into boardwalk and bridge components. Additionally, Cleveland Metroparks Zoo will utilize harvested trees for zoo animal browse.

GMP 1 Establishment

Nerone has submitted the first GMP amendment, additional GMP's will be presented to the Board in a phased approach. Guaranteed Maximum Price 1 (GMP 1) is as follows, and includes Mobilization, Demobilization and Staking; Haul Road; and Tree Removal, Grubbing and Processing.

Staff will return to the Board for Guaranteed Maximum Price 2 (GMP 2) for the pond and stream restoration phase. Additional GMP's will be brought to the Board for additional project components.

Construction Schedule

Nerone's construction schedule associated with the proposed GMP 1 anticipates completing tree removal prior to April 1, 2022 to comply with federal regulations. Following permit approval and future adoption by the Board, the scope of work associated with GMP 2 is anticipated to commence construction in early 2022. Cleveland Metroparks staff will monitor construction progress and provide updates to the Board.

 (Originating Source: Sean E. McDermott, P.E., Chief Planning and Design Officer)

Background

On November 29, 2019, Cleveland Metroparks issued a Request for Qualifications (RFQu #6464) for interested parties to submit qualifications related to the design of Tropical Bear Exhibit (Project) at the Cleveland Metroparks Zoo.

The Project will involve the rehabilitation and expansion of the tropical bear exhibit yards and the rehabilitation of the interior bear holding facilities. The design of Project shall incorporate LEED design principles and embrace the Cleveland Metroparks Green Infrastructure and Sustainability guiding principles recognized in the Cleveland Metroparks 2020 Emerald Necklace Centennial Plan.

Cleveland Metroparks staff prepared RFQu #6464 and requested that the respondents demonstrate qualifications relative to unique challenges that the Project presents. Like

other successful projects recently completed at the Zoo, the Construction Manager at risk delivery model will be utilized for execution of the Project.

RFQu Response and Analysis

RFQu #6464 yielded seven (7) responses from highly qualified consultant teams. Qualifications were reviewed by Cleveland Metroparks staff and, pursuant to O.R.C. 153.69, the top three (3) firms were ranked in order of most qualified. Sean McDermott, Christopher Kuhar, Andy Simons, and Christopher Lowe reviewed the qualifications upon submission and verified recently the top ranked teams' qualifications. A summary of the interested design teams is provided in the table below. As determined by staff, Van Auken Akins Architects, LLC (VAA) of Cleveland, Ohio has been deemed as the most qualified. VAA's team includes WDM, Thorson Baker, SBM, Environmental Design Group, and other well respected and talented sub-consultants. VAA and team has performed extremely well on past exhibit projects including Rosebrough Tiger Passage and Asian Highlands. Following VAA's top ranking is PGAV Destinations (No. 2) and Bostwick Design Partnership (No. 3).

(I) Ratification of Collective Bargaining Agreement with the Fraternal Order of Police, Ohio Labor Council, Inc.

Multiple collective bargaining agreements have been negotiated with the Fraternal Order of Police, Ohio Labor Council Inc. ("FOP") for both the Police Officer and Sergeant bargaining units. The first two agreements are one-year contract extensions from January 1, 2020 through December 31, 2020 for the Officers and Sergeants. These agreements contain no changes to the prior contract, including no wage increases.

The second two agreements are for a three-year period from January 1, 2021 through December 31, 2023. These agreements contain wage increases, the payment of a health insurance rebate, and the addition of Juneteenth as a holiday.

An FOP ratification meeting was held Thursday, August 5, 2021, with the membership ratifying both agreements.

The following is a summary of the financial impact of these agreements:

2020 - 0% wage increase

2021 - 3.5% wage increase and health insurance rebate

2022 - 2.5% wage increase

2023 – 2.5% wage increase (contingent upon passage of a new levy)

Health benefits premium contributions levels are maintained for the duration of the agreement (Plan A - 18%/Plan B - 13%) and Cleveland Metroparks will continue to incorporate a \$100.00 spousal surcharge.

<u>RECOMMENDED ACTION</u>:

That the Board authorize the Chief Executive Officer to execute collective bargaining agreements, in a form approved by Counsel and the Chief Human Resources Officer, with the FOP for 2020 and for the three-year period from January 1, 2021 through December 31, 2023.

Vendor unable to commit to a price or usage amount. Horse Meat/Short Loin product will be offered at current availability and market price until supply chain stabilizes.

Background

The Director of Procurement and Zoo staff have designated Central Nebraska Packing as a single source for product consistency in both nutritional guarantees and textures, and they provide a more reliable scheduling and ordering efficiencies. Although different companies may have similar base ingredients there are differences in composition. These differences would require an extensive transition time for many species with no guarantees of success. Historically, experimental usage of different suppliers consistently resulted in an inferior product with excessive amounts of sinew due to the differences in the way other suppliers processed the meats. In short, testing of competitive product consistently produced the Central Nebraska Packing products as superior.

As well, Central Nebraska Packing has a proven track record of product availability. Most of Cleveland Metroparks Zoo's needs are horse meat-based products. A couple of the other vendors have processing plants outside of the United States. As such, the regulations on processing horse meat are stricter for Central Nebraska Packing, which ensures health and safety standards are met.

Estimated expenditures are based on current animal population and consumption. Animal population may vary throughout the contract period.

SINGLE SOURCE #6591 SUMMARY: EUCALYPTUS BROWSE to be supplied for a two (2) year period beginning September 1, 2021 through August 31, 2023

Background

This single source requires a split award to provide Eucalyptus Browse for the Cleveland Metroparks Zoo on an "as needed basis." The dual award by Koala Browse of Boyton Beach, Florida and Australian Outback Plantation, Tonopah, Arizona, assures Cleveland Metroparks is not reliant upon one producer if growing conditions prevent an adequate harvest.

Weather conditions, disease and insect infestation of the eucalyptus varies between provider regions. Browse nutrition and leaf condition is also varied due to soil conditions, temperatures, season, and amount of rainfall. Growing conditions affect the nutritional quality of the plant resulting in inconsistencies in the koalas' consumption of the eucalyptus browse.

Keepers are unable to determine or predict which leaves or species the animals will prefer on a day-to-day basis. Additionally, there is a difference in species of eucalyptus provided by each supplier. Australian Outback Plantation provides between 17 and 25 different species of eucalyptus weekly which provides variety in the koalas' diet.

Minimally two (2) koalas, one (1) male and one (1) female, are projected to be in the Zoo's collection during the term of this bid. Shipping of eucalyptus browse (packed in ice as needed during warm months) is sent via Southwest Airlines. Koala Browse's shipping costs are billed separately.

<u>RECOMMENDED ACTION:</u>

That the Board authorize Single Source #6591, for a two (2) year period beginning September 1, 2021 through August 31, 2023, in an amount not to exceed \$115,000 including browse that is packed in ice from Australian Outback Plantation at a price of \$6.75/pound, and \$4.40/pound (\$22.00/bundle) from Koala Browse. In the event the log of consumption approaches 90 percent of the total estimate, an action item will be presented to the Board requesting an increase.

BID #6594 SUMMARY: 2021 PARKWAY AND TRAIL ASPHALT PAVING, SOUTH CHAGRIN RESERVATION

(Originating Sources: Joseph V. Roszak, Chief Operating Officer/Jim Rodstrom, Director of Construction)

Cleveland Metroparks has developed and successfully utilized pavement rehabilitation techniques consisting of simple overlays on pavements with good structural characteristics or a varying degree of pavement repair followed by an overlay on pavements with sections in poor condition or lack of structural integrity. The 2021 Parkway and Trail Asphalt Paving is proposed to utilize a repair and overlay approach similar to comparable projects completed over the past several years. Funding for these improvements will be from the 2021 capital project budget.

This 2021 asphalt resurfacing bid reflects the following scope of work:

1-1/2" asphalt overlay of approximately 4.25 miles of roadway with a typical pavement
width of 22 feet on Hawthorn Parkway in South Chagrin Reservation. 1-1/2" asphalt

INFORMATION/BRIEFING ITEMS/POLICY.

(a) 2021 National Procurement Institute (NPI) Achievement of Excellence Award (Originating Sources: William Chorba, Chief Financial Officer/Charlie Rosol, Director of Procurement)

Cleveland Metroparks Procurement Team has been awarded the prestigious 26th Annual Achievement of Excellence in Procurement® (AEP) for 2021 from the National Procurement Institute, Inc. (NPI). The AEP Award is earned by public and non-profit organizations that obtain a high application score based on standardized criteria. The AEP is awarded annually to recognize overall Best Practices, Innovation, Professionalism, E-Procurement, Productivity, and Leadership in the procurement function. This is the 12th time (11th consecutive) Cleveland Metroparks Procurement Team has won this award.

2021 saw 181 successful applicants, including 66 cities, 41 counties, 36 special districts, 19 school districts, 12 higher education agencies, seven (7) state/provincial agencies and two (2) other municipalities. Cleveland Metroparks was one of only two Ohio agencies and one of the 36 special districts in the United States and Canada to win the award.

(b) *First Tee Cleveland – Facility Expansion Proposal – Washington Golf Course* (Originating Source: Sean E. McDermott, P.E., Chief Planning and Design Officer)

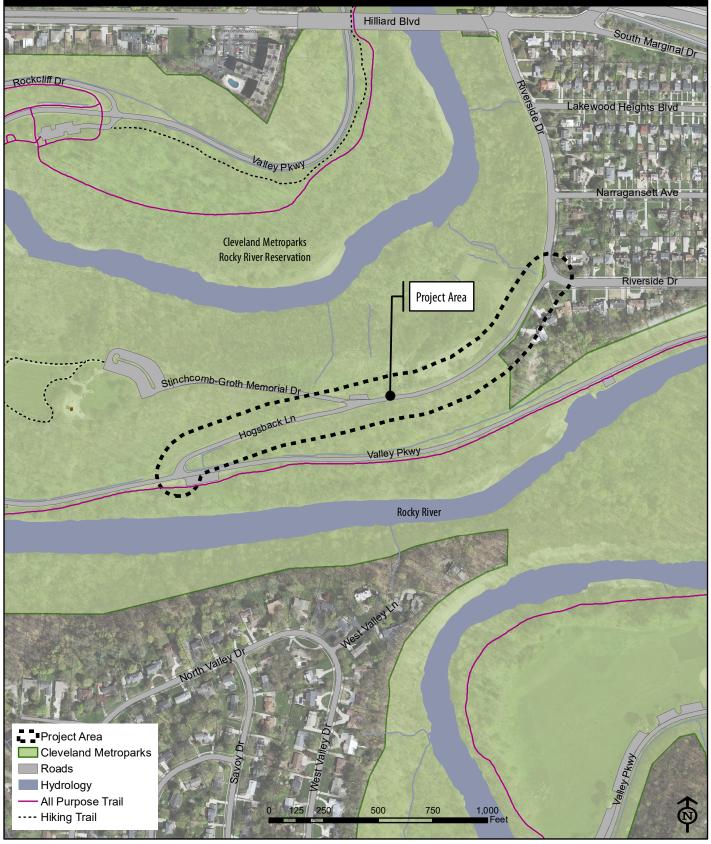

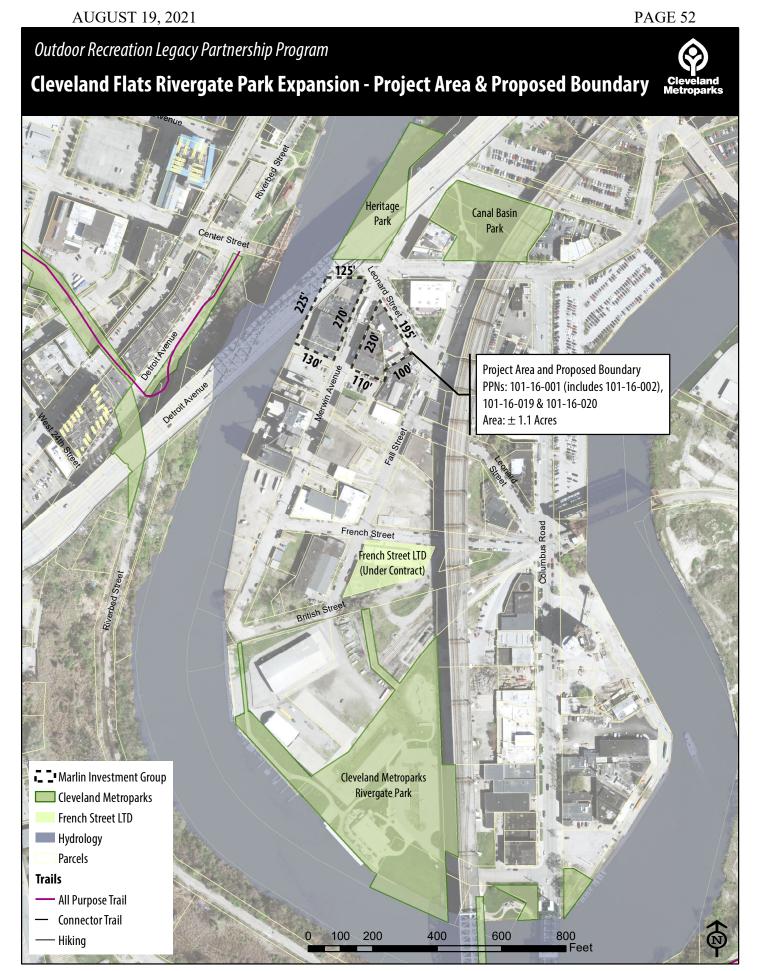

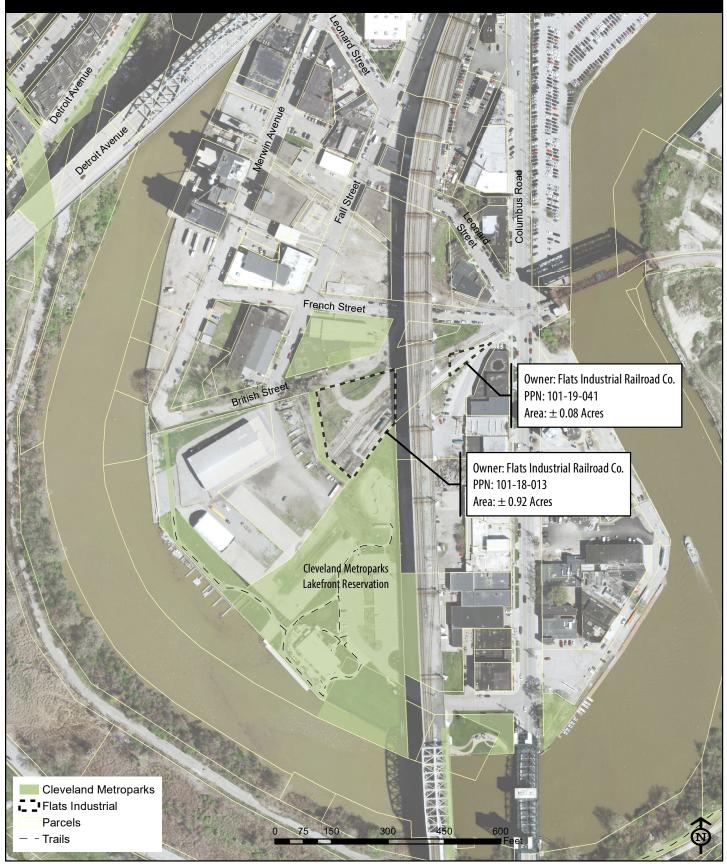

The Chief Executive Officer of this Board is hereby authorized and directed, in the manner and as provided in Section 731.23, Ohio Revised Code, to cause to be published in the manner required by that Section the revised provisions contained in the Codified Rules and Regulations and to give notice of the approval, adoption and enactment of the changes to the Codified Rules and Regulations except that such publication shall be made in The Cleveland *Plain Dealer* and the *Medina Gazette*.

Section 3. This Board finds and determines that all formal actions of the Board concerning and relating to the adoption of the changes to regulations were taken in an open meeting of this Board and that all deliberations of this Board and of any committees that resulted in those formal actions were in meetings open to the public in compliance with the law.

Section 4. This resolution shall be effective immediately upon its adoption by this Board, provided that the Codified Rules and Regulations revised by this resolution shall become and be effective from and after 12:01 a.m. Eastern Standard Time on September 18, 2021.
