She's almost 3 years old now. She can now say her ABC's and brush her own teeth and feed the cat and sing us long detailed songs about her day. It's been a year since Scene published an update. Good afternoon. Thank you for commenting, and I understand your frustration. The bridge construction project you are referring to is a Cuyahoga County Department of Public Works project for the "Cedar Point Bridge 00.49" while Cleveland Metroparks' upcoming project is in a similar location but is on Valley Parkway, not Cedar Point Road. I've copied the County on this email so you may reach out to them with any additional questions.

This project is expected to begin construction in fall 2024 and will last approximately 12 months. There will be a full closure of Valley Parkway in this area and the detour map is available in the link above.

The Cuyahoga County Cedar Point Bridge project, with which Cleveland Metroparks coordinated as a stakeholder, ran into unexpected conditions during demolition whereby the interior beams were much more corroded and impacted than samples and testing indicated during the design process. For bridge projects, whenever possible existing piers, abutments, and beams are typically reutilized and when it results in similar future useful life of the structure versus a more extensive rehabilitation or replacement to help lower costs and to make for faster construction to keep impacts of detours to the public as low as possible. The County's project webpage provides updates from throughout the project life, and the entry for February 10, 2023 explains what happened to cause the delay in detail. According to the latest information on the page, the

completion date is listed as November 1, 2024.
