

**Ledge Pool Facility  
Regulations:**

- Obey lifeguard instructions at all times
- No diving, headfirst entries or flips from pool sides
- No alcohol or drugs
- Children eight (8) years and under must have adult (age 18+) supervision
- No flotation devices (unless U.S. Coast Guard Approved)
- No masks, snorkels or SCUBA equipment
- No holding breath for long periods of time
- No glass containers
- No pets inside fenced area
- Swim diapers required for infants and small children
- No riding wheeled vehicles inside the fence
- No running
- No smoking inside fenced area
- No spitting, spouting of water, nose blowing, urination or human waste in the water
- Access to the water for any person with open sores or wounds is not permitted

**Closing Policy:** Ledge Pool may close at the manager's discretion based on inclement weather, attendance or unusual circumstances. If you have any doubt about the facility being open, please call Ledge Pool at 330-239-2911.

**Group Use Permit for Cleveland Metroparks Ledge Pool**

The following rules and regulations have been established by Cleveland Metroparks to increase the safety and govern the usage of its public swimming pool by all groups of swimmers. A group is defined as 10 or more individuals.

- Upon entering the facility the following group supervisor/child ratios must be maintained:
 

Toddlers (1-3 years):	1 Supervisor for every 2 Children
Preschool (4-5 years):	1 Supervisor for every 4 Children
School-Aged (6+):	1 Supervisor for every 6 Children
- All groups must check in and present a ticket per person in attendance. One group supervisor shall be designated by the group to act as the liaison to Cleveland Metroparks staff. The group supervisor must be at least 18 years of age; all other chaperones must be at least 16 years old.
- The group supervisors are required to be in the pool actively participating with participants under the age of 8. Lounging on the deck or supervising from outside the pool is NOT permitted unless your organization provides more than the required number of group supervisors.
- Each child that does not meet the height minimum will be required to take a swim test prior to entering the pool to determine swimmers from non-swimmers. ALL non-swimmers will be required to wear a lifejacket.
- Ledge Pool staff has the right to deny access to groups if: the daily group limit has been reached (90 group participants), there is not sufficient supervision (see above ratios), or inclement weather.
- Tickets must be purchased with signed permit at least two (2) weeks in advance in order to receive the \$5.00 per ticket discount. Tickets will be printed with the date of the visit and will only be valid for that date.
- The adults in attendance with the group are expected to support the Ledge Pool Staff in the enforcement of all rules and regulations.

**Failure to comply with any or all of the above requirements will result in the denial of facility use**
